This Petroleum Hospitality Agreement between **TAZAMA PETROLEUM PRODUCTS LIMITED** of Stand No. 415a, Mafuta Road, Bwana Mkubwa, P O Box 71651, NDOLA, Hereafter called "Landlord" and **QENN CARGO LIMITED** of Plot No. 2797 Great North, Thorn Park, LUSAKA, Hereafter called "Tenant" is made this **19th Day of November, 2024**.

The Landlord Hereby Agrees to provide Petroleum Hospitality to the Tenant of **150m³ of Diesel** and **100m³ of Petrol** storage Space, subject to availability of ullage or space at Ndola Fuel Terminal; complete with its auxiliary equipment located in **NDOLA**, Copperbelt Province of Zambia for **Petroleum Storage** Use for a period of **One (1) Year**.

The Landlord and The Tenant Agree to the following Terms and Conditions for Hospitality:

- A fixed capacity storage fee of US\$5 per cubic meter (M³) of stock balance at the end of the month.
- Loss of 0.3% and 0.5% on the Diesel and Petrol respectively shall be applied at the point of receiving and on book balance at the beginning of every month.
- Offloading charge of US\$5 per cubic meter shall be paid by the Tenant.
- Throughput charge of K62.64 per cubic meter shall be paid by the Tenant.
- The fuel shall be sampled and analysed at an independent laboratory at the Tenant's cost prior to offloading into the Landlord storage tanks.
